Practice times are either 5:30 – 6:30 or 6:30 – 7:30 (except at Fountain City Elementary School). You can start BEFORE 5:30 or stay AFTER 7:30, but your 5:30 practice must end by 6:30 to make room for the next team coming in ... and the 6:30 teams must WAIT until 6:30 to start your practice to give the 5:30 team their full field time.

No team may just SHOW UP to use a practice area. All practices at our approved locations must be reserved through the practice scheduler. The team whose name appears on the web site is who gets to use the field. The practice schedule will be updated frequently on the website (www.ayso337.com) so that everyone will know where all the teams are practicing.

AYSO can and will provide you with liability insurance forms to cover any other site that you can use to practice. We are ALWAYS in need of additional practice space, so if you have access to an area where everyone could practice ... or just your team ... don't hesitate to ask for a liability waiver. We have some teams who have practiced in their neighborhood ... it helps to be creative.

Please remember that we are guests at these locations and we have Knox County School board approval to be there. However, if we mistreat the area we could easily lose that location. We are not to go in the buildings for ANY reasons. They do not provide us access to use the restroom or water fountain ... we are strictly limited to using the playing field or play ground areas. Please treat these areas with respect at all times.
